Pioneer completes A\$40m medium term note issue

Further to the announcements dated 8 and 14 March 2018, Pioneer Credit Limited (ASX: PNC) (“Pioneer”) announces that it has today completed the issue of A\$40 million medium term notes (“Notes” or the “Offer”).

The Notes lengthen Pioneer’s debt maturity profile, diversify its funding sources and deliver a funding structure which supports Pioneer’s medium term growth ambitions, including the rollout of its new personal lending product through Pioneer Credit Connect.

Acacia Partners acted as the Arranger and as a Joint Lead Manager with Westpac Institutional Bank to the Offer.

For a summary of the key terms of the Notes, please refer to the ASX announcement dated 8 March 2018.

The Offer was only open to eligible Professional and Sophisticated Investors in accordance with Part 6D.2 of the Corporations Act 2001 (Cth).
